
Guide to Parish Council collections at Barnsley Archives & Local Studies



INTRODUCTION TO OUR PARISH COUNCIL COLLECTIONS

Parish councils for rural areas were originally created as a result of the 1894 Local Government Act and are responsible for a particular area known as a civil parish. Parish and town councils make up the tier of local government which is closest to the people. Smaller rural areas which are not large enough to form a parish council can hold a regular parish meeting instead.

Parish and town councils are central to local activity in their communities. They give people the opportunity to get involved in local affairs, events and campaigns, and encourage them to make their views known, particularly on issues about maintaining the character of the local area. People can also seek election to their local parish or town council. An important role of parish and town councils is to make other public bodies, like Barnsley Council, aware of the views of their communities.

Individual parish or town councils provide varying facilities, but most look after at least some recreational facilities and are involved in organising local events in their areas. All have the power to raise money for these activities through a precept, which is an extra amount of council tax paid by people who live in the parish or town. A civil parish can exist without necessarily having a parish council, at any time.



We hold further sources that relate and refer to parish councils in the Barnsley area. These include printed books, newspapers and other local government records. Consult a member of staff in the public searchroom or view the <u>online library</u> catalogue for further information.

Access restrictions are noted in the relevant catalogues. However, personal information can be obtained from recent and sensitive material by the person it relates to.
